Post Entry Fees: \$30 additional if postmarked after May 7; Entry Fee Refund Policy: Scratches must be received in writing prior to May 7 and will be refunded all but a \$25 handling free. No refunds after the closing date. Stall Fee: \$22/night for GMHA Members, \$35/ non members. No bedding provided, stalls must be stripped prior to departure.; Stall Deposit: None, \$50 dirty stall fee. Stall Refund Policy: Same as entry refund policy.; Other Fees: Bagged Shavings: \$10/ bag; Make Checks Payable to: GMHA, we also accept Visa and Mastercard.
